### OFFICIAL CONTEST RULES & REGULATIONS

"2021 Co-op Kids Club Pumpkin Painting Contest"

---

"**Co-op Kids Club Pumpkin Painting Contest**" (the "**Contest**") is sponsored by North Central Co-operative Association (the "**Sponsor**"). The Contest opens 7:00 am MST October 4<sup>th</sup>, 2021 (the "**Contest Start Date**") and ends 2:00 pm MST October 28<sup>th</sup>, 2021 (the "**Contest Closing Date**"), known as the "**Contest Period**".

The Contest is being promoted on North Central Co-op Facebook site in the province of Alberta– ("**Participating Stores**").

#### 1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

A parent or guardian must officially register their child in the contest on the official contest site ([northcentralcoop.crs](http://northcentralcoop.crs)). The child must be a Co-op Kids Club Member to participate.

- Pumpkins are to be painted or coloured, NOT carved. Other materials may be added to decorate the pumpkins (ex. Ribbon, cloth, construction paper, buttons, sequins, etc.).
- North Central Co-op will provide the pumpkins; however, paint and other supplies are the participants responsibility.
- Pumpkins must be supplied by North Central Co-op.
- One entry per North Central Co-op Kids Club Member.
- All entries should be dropped off at your designated Co-op Food Store location before October 18<sup>th</sup>, 2021.
- If you would like to take your pumpkin home after the contest, your pumpkin entries need to be picked up on either October 29<sup>th</sup>, 30<sup>th</sup> or 31<sup>st</sup>. Pumpkins that are not picked up by the end of day on the 31<sup>st</sup>, will go to the pumpkin graveyard.
- To be clear, this is a children's contest and parent involvement should be limited. Our teams have the right to disqualify any entries that appear to have too much parent or guardian involvement.
- Shoppers that make a purchase, will be given the opportunity to place a vote with the cashier.

#### 2. ELIGIBILITY:

##### Eligible

To enter the Contest and be eligible to participate and win a prize in the Contest, an entrant must be a resident of or live in proximity to Edmonton, Stony Plain or Fort Saskatchewan. Minors who enter must have the written consent of a parent or legal guardian in order to be eligible to receive any prizes.

##### Not Eligible

Residents outside of or not in proximity to Edmonton, Stony Plain or Fort Saskatchewan are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Directors as well as the immediate family\* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest. Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family\* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family\* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

\* "Immediate family" means members living in the same household.

### 3. PRIZE:

**Age 5 and under, Age 6 – 9, Age 10-12 – \$100 Co-op Kids Club Gift Card**

**APPROXIMATE RETAIL VALUE \$100.00**

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

### 4. PRIZE WINNER:

Customers and shoppers will be prompted to vote for their favourite pumpkin at checkout. Our cashiers, with no vested interest, will keep a tally of votes. The selected entrant will be contacted on October 28th, 2021. If a selected entrant cannot be contacted within one day of the draw date his/her entry will be disqualified and another entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within one day of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.

### 5. GENERAL:

By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. All entries become the property of the Sponsor and none will be returned. By entering this Contest, entrants consent to the use of their name and address (city and province) by the Sponsor for the purposes stated herein.

The Sponsor reserves the right to disqualify any entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Entry forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with, or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by selecting among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.
