### OFFICIAL CONTEST RULES & REGULATIONS

"Rock Your Reno \$1000 Giveaway – Fall 2021"

"**Rock Your Reno \$1000 Giveaway – Fall 2021**" (the "**Contest**") is sponsored by North Central Co-operative Association (the "**Sponsor**"). The Contest begins 8:00 am MST October 7<sup>th</sup>, 2021 (the "**Contest Start Date**") and ends 7:00 pm MST November 7<sup>th</sup>, 2021 (the "**Contest Closing Date**"), known as the "**Contest Period**".

The Contest is being promoted on North Central Co-op's Facebook & Instagram sites in the provinces Alberta– ("**Participating Stores**").

#### 1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

There are two (2) ways to enter the Contest, as follows:

Entrants must purchase qualifying products (faucets, vanities, lighting fixtures, ceiling grid and tiles, interior doors, thermostats, flooring, toilets, mouldings) from the Stony Plain Co-op Home Centre between October 7<sup>th</sup> and November 7<sup>th</sup> and upload their receipt online at [www.northcentralcoop.crs](http://www.northcentralcoop.crs).

No Purchase Entry Method: To obtain one (1) Entry without making an Eligible Purchase, an Eligible Entrant must print name, address and phone number on a plain piece of paper and mail it to the North Central Cooperative Association, c/o My Brother Darryl, 318 North Park Drive Stony Plain, AB, T7Z 0J5 ("No Purchase Entry"). Upon receipt of a No Purchase Entry in accordance with these Contest rules, the Eligible Entrant will be entered into the Contest. To be eligible, a No Purchase Entry submitted must:

- (i) be received separately in an envelope bearing sufficient postage (i.e. multiple Entries in the same envelope will be void); and
- (ii) be postmarked by October 30<sup>th</sup>, 2021 and received no later than November 5<sup>th</sup>, 2021 by 9:00:00 a.m. MST

#### 2. ELIGIBILITY:

##### Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of or live in proximity to Edmonton, Fort Saskatchewan, Stony Plain, Sherwood Park or Spruce Grove and the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

##### Not Eligible

Residents outside of or not in proximity to Edmonton, Fort Saskatchewan, Stony Plain, Sherwood Park or Spruce Grove are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family\* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family\* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family\* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

\* "Immediate family" means members living in the same household.

### 3. PRIZE:

**One (1) \$1000 Co-op Home Centre Gift Card**

**APPROXIMATE RETAIL VALUE \$1000.00**

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

### 4. PRIZE WINNER:

One winner will be selected at random from all valid entries on Monday, November 8th, 2021 at approximately 10:00 am. The selected entrant will be contacted within seven days of the decision date. If a selected entrant cannot be contacted within seven days of the draw date his/her entry will be disqualified and another entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question administered by the Sponsor and (2) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor. If the selected entrant cannot be contacted with seven (7) day, the location reserves the right to draw again.

### 5. GENERAL:

By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. The Sponsor reserves the right to disqualify any entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Entry forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with, or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by selecting among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.
