OFFICIAL CONTEST RULES & REGULATIONS

"75 Days Till Summer"

"75 Days Till Summer" (the **"Contest"**) is sponsored by North Central Co-operative Association (the **"Sponsor"**). The Contest opens 7:00 am MST April 7, 2021 (the **"Contest Start Date"**) and ends 2:00 pm MST June 20th, 2021 (the **"Contest Closing Date"**), known as the **"Contest Period"**.

The Contest is being promoted at all North Central Co-op Food Stores, Gas Bars and Home Centre in the province of Alberta– (**"Participating Stores"**).

1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

There are two (2) ways to enter the Contest, as follows:

Enter till receipt obtained from any purchase from any of the North Central Co-op participating locations.

No Purchase Entry Method: To obtain one (1) Entry without making an Eligible Purchase, an Eligible Entrant must print name, address and phone number on a plain piece of paper and mail it to the North Central Co-operative Association, c/o My Brother Darryl, 318 North Park Drive Stony Plain, AB, T7Z 0J5 ("No Purchase Entry"). Upon receipt of a No Purchase Entry in accordance with these Contest rules, the Eligible Entrant will be entered into the Contest. To be eligible, a No Purchase Entry submitted must:

(i) be received separately in an envelope bearing sufficient postage (i.e. multiple Entries in the same envelope will be void); and

(ii) be postmarked by June 12th, 2021 and received no later than June 19th, 2021 by 9:00:00 a.m. MST

2. ELIGIBILITY:

Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of or live-in proximity to Edmonton, Stony Plain, Spruce Grove, Sherwood Park, Legal, St Albert or Fort Saskatchewan and be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Residents outside of or not in proximity to Edmonton, Stony Plain, Spruce Grove, Sherwood Park, Legal, St Albert or Fort Saskatchewan are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within one day of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.
