OFFICIAL CONTEST RULES & REGULATIONS

"Co-op Kids Club Find Your Summer Giveaway (2023)"

The North Central Co-op Kids Club Find Your Summer Giveaway (the "**Contest**") is sponsored by North Central Cooperative Association (the "**Sponsor**"). The Contest begins 7:00:00 a.m. (MST) on June 1st, 2023 (the "**Contest Start Date**") and continues until 2:00:00 p.m. (MST) on June 30th, 2023 (the "**Contest Closing Date**"), known as the "**Contest Period**".

1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

To enter the Contest:

- Must have a child (or children) under the age of 12 registered in North Central Co-op Kids Club before the contest close date.
- One (1) entry into the contest will be earned for every child under 12 registered in North Central Co-op Kids Club.

All valid entries must be received on or before end of day on June 30th, 2023 before 2:00 pm.

2. ELIGIBILITY:

<u>Eligible</u>

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of or live in proximity to Edmonton, Stony Plain or Fort Saskatchewan and be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Residents outside of or not in proximity to the defined radius are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's member retail co-operatives ("**Co-ops**"), the Co-ops' Board of Directors as well as the immediate family* and those domiciled with the Co-ops' employees and the Co-ops' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Co-ops' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

* "Immediate family" includes parents, siblings, children and spouses.

The chances of being selected are dependent upon the total number of eligible entries received during the Contest Period.

4. PRIZE WINNER:

Three (3) winners will be drawn at random from all valid entries on:

• Wednesday June 30th, 2023 at approximately 3:30 pm for each corresponding prize.

To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question administered by the Sponsor and (2) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor. If the selected entrant cannot be contacted with one (1) day, the Sponsor reserves the right to draw again.

5. GENERAL:

By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. In the Sponsor's sole discretion, a Prize Winner may be selected by randomly drawing from among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, member retail co-operatives, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its member retail co-operatives, subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

6. PRIVACY:

The Sponsor, North Central Co-operative Association, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties. The Sponsor will use the information collected solely to administer the Contest. No correspondence will be entered into except with selected entrants. North Central Co-operative Association will handle personal information in accordance with its privacy policies and practices, which can be accessed on its <u>website</u> or by contacting North Central Co-operative Administrative Office and in accordance with applicable laws. By completing and submitting a Contest entry form you consent to the collection use and disclosure of your personal information for the purposes stated herein.
