OFFICIAL CONTEST RULES & REGULATIONS

"Co-op Kids Club Hey Clay Classroom Contest"

"Co-op Kids Club Hey Clay Classroom Contest" (the **"Contest"**) is sponsored by North Central Co-operative Association (the **"Sponsor"**). The Contest begins 8:00 am MST Tuesday September 14, 2021 (the **"Contest Start Date"**) and ends 2:00 pm MST Monday October 25, 2021 (the **"Contest Closing Date"**), known as the **"Contest Period"**.

The Contest is being promoted at participating North Central Co-op Food Store location in the province of Alberta– (**"Participating Stores"**).

1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

To participate, Entrants must successfully complete the official contest registration form available on the official contest website, northcentralcoop.crs, and receive approval from the contest official Sponsor to compete. The Entrants must create a sculptor, sculptors or clay creation incorporating some of the zofficial Co-op Hey Clay product provided by the Sponsor for the purposes of this contest and either upload or email a photo submission to North Central Co-op on or before October 18, 2021. One entry per classroom.

2. ELIGIBILITY:

Eligible

To enter the Contest and be eligible to win a prize in the Contest, the Entrant must be a teacher, instructor or administrator at a school within North Central Co-op trading area (see below definition), and be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

North Central Co-op trading area: 5km radius of urban locations (Chappelle, Hawkstone, Town Centre) and 25 km of rural locations (Stony Plain, Fort Saskatchewan). However, each application will be reviewed to determine eligibility.

Not Eligible

Schools and their administration outside of or not in proximity to Edmonton, Stony Plain or Fort Saskatchewan are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

* "Immediate family" means members living in the same household.

3. PRIZE:

APPROXIMATE RETAIL VALUE \$600

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

4. PRIZE WINNER:

The Sponsor will evaluate and determine the top five (5) submissions based on creativity (3 points), originality (3 points), attention to detail (3 points) and execution (3 points) for a total score out of twelve (12). A bonus point will also be awarded to submissions that incorporate the Co-op in some capacity. The top five (5) finalist submissions will be shared online and the general public will vote from October 21, 2021 until October 25, 2021. The Entrant with the greatest number of votes will be contacted shortly after the contest closes. If this Entrant cannot be contacted within two business days, his/her entry will be forfeit to the next Entrant. To be declared a prize winner (the "Prize Winner"), the Entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within one day of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. The Prize Winner must consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.

5. GENERAL:

By entering the Contest, Entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. All photo entries become the property of the Sponsor and none will be returned. The teacher, instructor or administrator that registered the classroom will be considered the "Entrant". By entering this Contest, the Entrants consent to the use of their name and address (city and province) by the Sponsor for the purposes stated herein. Note, the names of students will not be publicized. All public facing communication will state the teachers name and the school that participated. For example, "Mrs. Krabappel's class from Springfield Elementary participated in North Central Co-op's classroom contest".

The Sponsor reserves the right to disqualify any Entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Registration forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with, or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by selecting among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, Entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

6. PRIVACY:

The Sponsor, North Central Co-operative Association, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties.

The Sponsor may use the information collected to: administer the Contest; to send you email offers and communications from North Central Co-op which includes notices of sale specials, promotional offers, contests, special events, and new products and services; to contact you from time to time to invite you to provide your opinion and feedback on Co-op

products and services. If you no longer wish to receive emails from Co-op you may click the unsubscribe link that appears at the bottom of every email.
