OFFICIAL CONTEST RULES & REGULATIONS

"Letters to Elfie Contest"

"**Letters to Elfie Contest**" (the "**Contest**") is sponsored by North Central Co-operative Association (the "**Sponsor**"). The Contest opens 8:00 am MST November 21st, 2024 (the "**Contest Start Date**") and ends 10:00 pm MST December 11th, 2024 (the "**Contest Closing Date**"), known as the "**Contest Period**".

The Contest is being promoted at all North Central Co-op Food Stores, Gas Bars, and the Home Centre in the province of Alberta– ("**Participating Stores**").

1. **HOW TO ENTER:**

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

To enter, an eligible participant must visit a Participating Store, find the Letters to Elfie letter box located somewhere in the Participating Store, write out your Christmas wish list on official contest letterhead, correctly include all requested fields on the back of the letterhead, and place into the letter box. All valid entries must be received on or before the contest close date. Winner will be randomly selected from all valid entries across all Participating Stores.

2. **ELIGIBILITY:**

Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of or live-in proximity to Edmonton, Stony Plain, Spruce Grove, Sherwood Park, Legal, St Albert, Fort Saskatchewan or Edson and be the age of Co-op Kids Club membership, with a parent or guardian the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Residents outside of or not in proximity to Edmonton, Stony Plain, Spruce Grove, Sherwood Park, Legal, St Albert, Fort Saskatchewan or Edson are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

Persons that are outside of the age range of Kids Club Membership (12 years of age or younger) are not eligible.

* "Immediate family" means members living in the same household.

3. **PRIZE:**

One (1) maximum \$1,000 Holiday Wish List prize

Prizes must be accepted as awarded. Prizes may not be converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

4. PRIZE WINNER:

One (1) selected Entrant will be randomly selected on December 12st, 2024 from all valid Entries. The selected Entrant will be contacted shortly afterwards. If a selected Entrant cannot be contacted within one (1) day of the draw date his/her entry will be disqualified and another Entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected Entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within one day of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.

The Sponsor reserves the right to disqualify any entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Entry forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with, or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by selecting among all valid entries received up to the time of cancellation, termination or suspension.

The Sponsor, North Central Co-operative Association, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties.

The Sponsor may use the information collected to: administer the Contest; to send you email offers and communications from North Central Co-op which includes notices of sale specials, promotional offers, contests, special events, and new products and services; to contact you from time to time to invite you to provide your opinion and feedback on Co-op products and services.
